The 11 – 16 Bursary Fund has been set up by Farmor's School to support students from households with financial constraints in the academic year 2025-26.

If your child is living in care or a care leaver, or has a parent/carer who is receiving Income Support or Universal Credit; or are disabled in receipt of Employment Support Allowance or Universal Credit and also in receipt of Disability Living Allowance or Personal Independence Payments you will be eligible to register to apply for support for a range of educational resources and activities. Registering means you can then apply for support as these resources are needed and activities arise.

You must submit original evidence documents to support your application. These will be photocopied by the school and retained as evidence.

Procedure

- 1. Application form to be completed by the parent/carer and submitted to Mrs Julie Simmonds with the required evidence by 20th September.
- 2. Your application will be assessed within 2 weeks of receipt.
- 3. You will then be informed of the decision; reasons will be given for rejection of an application in whole or in part.
- 5. Once the registration has been accepted provision may be available for immediate payments towards resources and educational trips.
- 6. If a student who has received financial assistance leaves the school, the parent/carer may be required to repay all or part of their bursary.
- 7. If a student joins mid-way through the year, they can apply to register within the first month of joining.
