Dear Headteacher,

I am writing to let you know about an NHS service which is available in Boots pharmacies across England, called the **NHS Pharmacy First Service.**

NHS Pharmacy First Service enables children and adults to get convenient access to advise and treatment where appropriate, for seven common conditions without the potential delay of having to wait for a GP appointment. There is no need to make an appointment with the pharmacy and parents or carers can pop into their local pharmacy with their child and ask for help under the service.

All Pharmacy First patients have a private consultation with a pharmacist, who provides advice and, if clinically appropriate, offer to supply treatment for the condition*. Should the pharmacist be unable to help, they will direct the person to their GP surgery or other healthcare professional as appropriate.

With the ever-increasing pressures on the NHS, particularly during these busy months, it is important to us, that we do all we can to support and we would really like your help in driving awareness of this fantastic service to your parents and carers and to encourage them to think **Pharmacy First.**

To support you with this, we have created a template communication on the second page of this letter which you could use in your regular communications to highlight the service to parents and carers.
