After July and onwards		
1.	Parents should contact the school of their choice, not the LA, to request a place.	Parents/Guardians
2.	The school will ask you to complete the Local Authority Common Application Form (CAF) for in-year admissions. This is sent to the LA for them to register your child on the county roll of students seeking a place.	Parents/Guardians
3.	If your preferred school does not have a place and you wish to appeal, the school will give you their appeal application form together with information about appeals contained in the "School Standards & Framework Act (extract)".
